

Northcountry Cooperative Development Fund Membership Application Instructions

Step 1: Determine whether you are applying as a cooperative organization or as an individual. Organizational members get one vote each while individual members are grouped together and get one collective vote. See bylaws for more information.

Step 2: Determine the amount of equity investment is necessary for membership. Equity for individual and credit union membership is \$10. Equity for cooperative organizations varies by type. Equity for housing co-ops is based on the number of units. The base amount is \$10 per unit, with a minimum \$150 and maximum of \$3,000. For other cooperative types the required equity is based on assets.

Step 3: Familiarize yourself with the bylaws of NCDF and with your rights and responsibilities as a member.

Step 4: Fill out appropriate sections of and sign enclosed membership application. Cooperative organizational applicants fill out top sections. Individual applicants fill out bottom sections.

Step 5: Mail application and equity payment to NCDF at:

Upon receipt of the application, your equity investment, and then approval by the NCDF Board of Directors, you will receive an acknowledgment from NCDF, as well as quarterly statements of account activity.
